In doing so you will need to show in your dissertation the ability to cross-relate different elements of MSP beyond that simply implied by the topic to demonstrate your understanding of how the different elements of MSP inter-relate.

Your dissertation should show the examiner how MSP guidance was used (or not) within the programme to deliver effective management in the chosen area. If the programme was not run under the MSP regime, then the candidate should explain how the management in the chosen area was undertaken and how it could have been improved by the use of MSP guidance.

Examinations

The format of the Advanced Practitioner Re-registration is a 2000 - 4000 word "dissertation". The Examination Board suggests a target of 2500 words on a specific subject (selected from a range of topics) demonstrating application of MSP.

This may seem like a lot of writing, but we work with you to develop ways of building this up. In fact, most of our candidates end with having to make choices on what to leave out.

Ideally, your dissertation will be based on a "real life" programme that you have worked within. If this is not possible (if you have not recently worked within a programme or your programme contains classified information), it would be acceptable to base it on the Advanced Practitioner Case Study "MSP Care".

There are no time restrictions imposed on this dissertation. The dissertation will be marked out of a possible 75 marks with a pass mark of 38 marks.
